# 1. About AidData

AidData is an initiative that aims to (a) increase the impact of development assistance by making aid information more transparent and accessible to a wide range of stakeholders, and (b) improve the quality of research on aid allocation and aid effectiveness. AidData provides a searchable database of nearly one million past and present aid activities around the world, aid information management services and tools, data visualization technologies, and research designed to increase understanding of development finance. Currently, the AidData team is working with a wide range of development organizations to collect, visualize, and leverage aid information in ways that will improve development policy, practice, and research.

The information available through the AidData database serves as a platform for testing new ways to make aid information more relevant for different audiences. For example, recent work on geocoding aid can help civil society organizations identify the aid-funded activities that are underway in their communities. AidData's work supports the efforts of the International Aid Transparency Initiative (IATI) by allowing users to download data in IATI format. Additionally, AidData Raw serves as a repository for datasets that have not yet been vetted or that are not appropriate for inclusion in the main AidData database but provide added informational value.

In order to build and maintain the core database of nearly one million aid activities around the world, AidData staff collaborate with partners at the Organisation for Economic Co-operation and Development (OECD) and with individual donor agencies and institutions to gather, standardize, and republish project-level aid information. Outreach to emerging donors and private foundations, which account for a growing share of global aid flows, is an important part of this work. Additional descriptive information is also culled from related documents, making it easier for users to understand how aid funds are being spent.

In addition to the resources it provides to the public, the AidData program provides services for development organizations that require custom solutions for managing or analyzing aid information.

## **About the User's Guide**

The AidData User's Guide describes the information available through the AidData website, which includes a search interface to the live data, static datasets for research purposes and additional datasets for some disbursement data. It shows where the data come from, how they relate to physical projects, the types of development finance covered, the additional detail of the sectors targeted by projects and deflation to constant US dollars. ## 2. What's in AidData

### 1.1. Introduction

The main AidData search table contains information on development finance activities for the period 1947-2011. The primary variables are compiled from a range of sources, including the OECD Creditor Reporting System (CRS) database, donor annual reports, project documents from both bilateral and multilateral aid agencies, data gathered directly from donor agency sources, and agency websites and databases.

### 1.2. Downloading AidData 2.0

There are three ways to access information in AidData: the *live website*, the *research release* and *raw data*. The live website provides the most current data available through AidData. The research release provides a thorough, comprehensive snapshot of the data for use by researchers and others who need a static copy of the information in AidData. Raw data gives access to other useful datasets not included in the main database.

#### ***AidData Live Website***

AidData staffers are constantly working to improve the data: cleaning up errors, filling in fields, adding additional years and new donors. New rows are published to the searchable live table after they have been added and coded. This helps us provide new data to users quickly but also means that on any given day the newest donor-year segments of data may only be partial (as some rows are still being coded or waiting for data to be provided). While the live database may contain partial donor-year segments, the data are more current than the latest research release.

#### ***Research Release***

AidData incorporates PLAID: a project founded and managed by university professors and development professionals who understand the needs of researchers. Research releases offer snapshots of the data that can be utilized by researchers and cited in scholarly work. These static versions of the data allow for replication and comparison by users. AidData's goal is to make updated research releases available annually (or more frequently if possible and appropriate).

#### ***AidData Raw***

AidData Raw is a group of datasets not yet included in AidData's main search interface or research releases, but which may be of use to the public. Because the work of integrating and standardizing data presents technical and methodological challenges not all datasets can be incorporated immediately. AidData Raw is depository where free-standing datasets are stored until such a time as they can be incorporated with AidData's main searchable table. These datasets come from a variety of sources and descriptions are included for each. Data may be more timely than the data included in the main search interface or it may just be an alternate view of the activities for that donor. Some datasets include only information from the donor themselves -- descriptive

information, financial details, etc. -- while others include added sector or geocodes created by AidData staffers.

While AidData has taken considerable care to ensure that this dataset is as error-free as possible, data vetting is an ongoing process. #### **1.5. Data Sources and Standardization**

The information available through AidData comes from a number of sources, including the OECD's Creditor Reporting System, annual reports and project documents published by donors, web-accessible databases and project documents, and spreadsheets and data exports obtained directly from donor agencies.

#### **1.6. AidData and OECD Creditor Reporting System (CRS)**

The majority of the activities in AidData are drawn from the Organisation for Economic Co-operation and Development's (OECD) Creditor Reporting System (CRS). The Aid Activity database of the DAC (the Creditor Reporting System) contains statistics on individual aid activities. The system – in existence since 1967 – is sponsored jointly by the OECD and the World Bank. It covers most of the bilateral activities of the 24 members of the OECD's Development Assistance Committee (DAC) as well as those of multilateral development banks, some UN agencies, some non-DAC donors and, from 2009, the Gates Foundation.

The CRS is updated on a regular basis with over 100,000 new grant and loan commitments added each year. These records include descriptive and financial information.

Some CRS disbursement records are at present excluded from the main AidData database. Please see "Commitment and Disbursement Amounts" below for more detail.

#### ***Previous Aid Flows***

Most of the CRS data in AidData 2.0 is pulled from the OECD website through the bulk download facility on the OECD.Stat portal. The CRS no longer includes past aid flows to countries that have graduated from eligibility for Official Development Assistance that were covered by CRS in previous years. Since flows to such previous aid recipients have some value to researchers, AidData has taken information on these flows from the 2009 edition of the OECD's International Development Statistics (IDS) CD-ROM. Throughout this document, this source is referred to as Previous Aid Flows. To see the donors, recipients, and recipient-year sets that were imported as Previous Aid Flows,

see the AidData User's Guide. Users who wish to include Previous Aid Flows may do so by including all records where the source field is equal to “Previous Aid Flows.”

In AidData version 2.0, two sources of CRS data – the complete May 2011 edition of the OECD.Stat dataset<sup>2</sup> and the Previous Aid Flows found in the IDS– are combined to create the most complete available data for each donor.

## 1.7. Other Sources for AidData Records

For donors who are not members of the OECD Development Assistance Committee (DAC) or do not report to the OECD CRS, AidData gathered data through many different channels. In some cases, the AidData team used alternate sources for donors also found in the OECD CRS. In these cases, the alternate sources contained additional information, including improved descriptions or Other Official Flows (OOF) not available in the OECD CRS. Alternate sources include annual reports, web-based project pages or direct data exports.

### ***Annual Reports***

Annual Reports served as the source for most multilateral development bank records as well as the many non-DAC bilateral donors. AidData gathered these reports from freely-available print or web resources.

### ***Web-Based Project Pages***

When data were made available online but not in easy-to-download formats, the AidData team used web-scraping tools to systematically and comprehensively capture the web-based information for the database. For example, AidData’s records for World Bank-funded activities were scraped from the World Bank’s project pages.

### ***Direct Data Exports***

Where suitable data for inclusion could not be found already in the public domain, the AidData team contacted donors directly. In many cases, donors happily provided AidData project-level information in the form of project documents, database exports, spreadsheets, or a combination of these formats. AidData formatted, standardized, and, if needed, translated these records for inclusion in AidData. Donors who provided us data directly had the opportunity to review their data prior to publication. In some cases, donors had never systematically reported on their aid activities before and AidData provided expertise and guidance on how to do so. As a result, some of these donors are only able to populate a small number of fields at this time. It is anticipated that data for these donors will improve in quality and quantity as they work with AidData to improve their data collection and reporting capacity.

## 1.8. Coverage and Completeness

With data spanning 64 years there is a wide range in the completeness of data, especially for earlier years. New donors are being added all the time to the datasets, as they report to CRS and/or direct to AidData, but they often do not provide data covering their activities in the years before they started reporting. This affects long time series, as

part of any perceived increase in aid volumes is simply due to covering more donors and more of their aid. Such analyses should thus be treated with circumspection.

Moreover many DAC donors have been gradually increasing the proportion of their aid that they report at activity level to the CRS over many years. As its name indicates, the Creditor Reporting System started as a system for recording commitments of loans (or credits). From the early 1990s, the DAC Secretariat has encouraged DAC donors to provide information on their grants as well as on their disbursements at activity level. From 2011 coverage for DAC donors should be complete. But some donors added their disbursements only in the early 2000s and Japan has been reporting its technical co-operation activities since 2003. Thus the CRS online system includes commitment data only from 1995 and expenditure data from 2002. The partial data for earlier years is included in the bulk download facility and incorporated in AidData.

Appendix A provides estimates of the coverage of the AidData records. For DAC donors this is calculated by comparing their CRS reporting with the aggregate data for total ODA commitments that they report separately to the DAC. For other donors there are no similar control totals available, but in some cases data are provided only for a few years and /or by some agencies within the country. This is indicated in the Notes column.

### 3. Types of Financing Tracked by AidData 2.0

AidData includes records for development financing activities from 1947 to 2011. *Development finance* is defined as loans, grants, or equity investments from governments, official government aid agencies, and inter-governmental organizations (IGOs) and private foundations intended to promote the economic development and welfare (broadly defined) of developing countries. This takes a broad view of development assistance, beyond Official Development Assistance (ODA).<sup>3</sup>

Our data therefore includes commitments that offer financing to developing countries in the form of:

- Grants
- Mixed loans and grants
- Loans at concessional rates from multilateral agencies
- Loans for development at market rates
- Technical assistance
- Sector program aid transfers in cash or in kind
- Some equity investment activities

For many activities it is possible to restrict the data selection criteria within the database to differentiate among project financing types using the *Flow Type*, *CRS Flow Name* or

*Grant Element* variables. For donors that do not explicitly state that a given commitment is a loan or a grant or both, these fields are left blank.

AidData **does not include** the following types of funding:

- Military equipment and services
- Military stock of debt
- Export credits or trade financing
- Loan guarantees
- Aid flows from non-governmental organizations<sup>4</sup>
- Private long-term capital
- Loans made out of funds held in the recipient country
- Foreign direct investment (FDI), unguaranteed bank lending, portfolio investment.
- Contributions to core funding of multilateral development organizations (Following the CRS reporting directives, flows from donor governments to multilateral organizations that are earmarked as “financing for specific projects” are reported.<sup>5</sup>)

## 4. Interpreting Activity Records

### 3.1. Unit of Analysis in AidData

AidData is working to create a *project-level* repository of development activities – one record per project. However, this is still work-in-progress and has not been implemented in this release of AidData 2.0.

At present AidData 2.0 is not a project-level aid database. It is rather an activity database where records can describe **either** a single project **or** a sub-component of that project, such as a single commitment or disbursement, **or**, in some cases, a group of projects in the same country and sector.

Thus in some instances, one record does contain all the information for a project: the total commitment amount, total disbursement amount and all of the descriptive information. However, in many cases a project-level unit of analysis is not possible, as information from donors and aggregators comes at different levels of aggregation and disaggregation. In particular, a single project can have many records in AidData divided across multiple years and even multiple sectors.

This does not affect figures for the total amount committed. But users should be aware that AidData record counts *do not* equate to project counts and so analysis of, for example, fragmentation cannot be based on the number of records in AidData.

### 3.2. Commitment and Disbursement Amounts

As data are gathered by diverse methods from many sources, it makes associating records that may refer to the same project different for every source. For example, the OECD CRS, one of AidData's largest sources, is a transaction-level database for reporting on annual commitments and disbursements. In the case of CRS information, many disbursement records cannot at present be reliably linked to commitment records for the same project. AidData is working with the OECD to investigate ways of linking commitment and disbursement records from this source. **But at present, records that only include disbursements are excluded from the AidData dataset.** This means that disbursement sums for OECD members do not reflect the values reported by the donor. **For complete information on OECD CRS disbursements, please visit the CRS website.**

Users should note that commitment records are imported in their entirety. The excluded disbursement records are also available for download here, should users wish to use them to complement AidData 2.0. ### 3.3. AidData's Primary Fields

Records in AidData contain over 100 fields, but many of these are tailored for specialized project reports or research questions<sup>6</sup>. Most users will find the most useful information in the following fields:

**Donor name:** Name of the donor country or multilateral organization. For more detailed information, use *Implementing Agency* and/or *Financing Agency*.

**Recipient name:** Name of the recipient country or region. In some cases, *Private Recipient*, *Beneficiary* or *Borrower* may contain relevant information.

**Year:** Commitment year. Other date fields may also contain useful values, but *Year* is always populated.

**Commitment Amount:** Amount the donor has agreed to provide for the duration of the project, often disbursed over the following years. Note that there are actually several commitment amount fields:

**Nominal/Current:** As reported by the donor, in the reported currency.

**Current (USD):** As reported by the donor, converted to nominal USD at the average exchange rate in effect in the commitment year.

**Constant (USD):** The reported amount converted to USD and adjusted for inflation and exchange rate changes. Constant amounts are all presented in USD2009 (i.e. at 2009 prices and exchange rates). See below for conversion and deflation methods.

**Title, Short Description, Long Description:** These fields contain descriptive information as provided by the donor. Long descriptions range from only a few sentences to several paragraphs in length.

**Purpose Code:** AidData has developed a granular system of sector coding, which expands the OECD’s purpose code scheme. However, coding is still underway. AidData researchers have coded projects from non-CRS sources and work is underway to add these codes to CRS-sourced data as well, but new codes have not yet been released for CRS projects. Therefore, CRS purpose codes for CRS-sourced records and AidData activity codes for non-CRS records should be used complementarily. See “AidData Sector Codes” and Appendix C for a full description of AidData’s codes and how to use them.

## 5. Currency Conversion and Deflation

Activities in AidData come from many diverse donors around the globe – and cover many years. To make these records useful for comparison across currencies and time, AidData has employed a systematic method to convert commitment and disbursement amounts to constant 2009 US dollar equivalents<sup>7</sup>. This method captures two basic changes in purchasing power over time:

**Inflation:** Inflation is the general rise in prices in a given economy over time, resulting in reduced buying power for currency of that economy. Using figures for GDP in both current and constant prices provided by OECD and the World Bank, an inflation percentage is created for the change in prices between the year of the commitment and the base year 2009.

**Change in Currency Exchange Rates:** Due to fluctuations in international markets and money supply, the relative strengths of the world’s currencies change over time. AidData’s deflators account for the change in exchange rates to the US dollar between the year associated with each record and the base year 2009.

AidData’s deflators (available here) represent the *relative buying power of 1 USD in 2009, compared to 1 USD worth of a local currency in a given year*.

For example, say the United Kingdom made a commitment of GBP 55 million in 2005 when 0.55 pounds bought one dollar. It was thus worth USD 100 million in 2005. To express this in 2009 dollars we need to adjust by inflation in the UK and the change in the exchange rate of the pound to the dollar. UK inflation was 10% between 2005 and 2009, so GBP 55 million in 2005 was worth GBP 60.5 million in 2009. In 2009 it took 0.64 pounds to buy a dollar, so the GBP 60.5 was worth USD 94.5 million ( $60.5 / 0.64$ ).

The deflators combine the two adjustments. First the exchange rate: the dollar was worth 1.164 as many pounds in 2009 as in 2005. Next, inflation: the pound bought only 0.909 times as much in 2009 as in 2005. The deflator is then  $1.164 * 0.909 = 1.05$ . To convert the 2005 UK flows expressed in 2005 dollars to 2009 dollars, divide them by this deflator, i.e.  $USD 100m / 1.05 = USD94.5m$ .

## 6. AidData's Sector Coding Scheme

AidData researchers have concluded that attaching only a single sector code often fails to capture the wide variety of development objectives aid projects seek to address. AidData has developed a coding scheme to address the complexity of such multi-purpose projects that allows researchers to capture their granularity as well as determine the project's dominant purpose.

The AidData coding scheme is an extension of the widely used OECD CRS purpose codes. However, the two diverge in non-trivial ways: where the OECD system seeks to capture a single overall purpose of any given aid project, AidData attempts to capture the overall purpose *and* each individual activity. Each project in the AidData coding system is coded for an overall purpose and at least one more detailed activity code, creating a more granular picture of development assistance.

Please refer to Appendix C for the complete AidData coding scheme.

### 5.1. Purpose Codes

Just as for the CRS, the AidData coding scheme assigns one purpose code for each project, which represents the dominant sector targeted by the project. The purpose codes for AidData's scheme are the same as the CRS's "main codes" except for a number of additional purpose codes that clarify and add detail. For example, *21010: Transport policy and administrative management* in the CRS scheme includes any project that is a combination of other transportation sub-sectors, and unspecified transport activities. In the AidData purpose coding scheme, these two items have been given their own codes—*21000: Transport and Storage, combination of purposes* and *21005: [unspecified transport activities]*. If the project fosters more than one sector, then the project will have a multi-sector purpose code.

### 5.2. Activity Codes

The AidData scheme is also useful at a more granular level. During the coding process, coders attach activity codes to each project based on information provided by the donor in the title and description fields. Every project is assigned at least one activity code, but there is no limit on the number of activity codes that can be associated with a particular record. It must be noted, however, that there is no attempt to allocate a percentage of the commitment amount that applies to each activity code. They are thus useful for descriptive analysis, but due to double counting cannot be used for quantitative analysis of aid to any particular activity code.

In the AidData 2.0 dataset, activity codes are presented as pipe-separated values in the *plaid\_activity\_code* field.

To date, the AidData coding scheme has been applied to over 70,400 activities in the dataset. Activity coding is underway for the remaining records.

### 5.3. Generated CRS Purpose Codes

Because the AidData coding scheme subsumes the original CRS structure with two sets of codes, users can make the data compatible with other OECD CRS coded data by

using the AidData-suggested OECD CRS purpose code. These codes are generated from the assigned AidData codes based on coding instructions in the “Clarifications/Additional notes on coverage” section of Annex 5 as well as the “detailed codes”<sup>8</sup> in the CRS coding scheme.

The activity codes for the new scheme are derived from the “Clarifications/ Additional notes on coverage” section of Annex 5 as well as the “detailed codes” in the CRS coding scheme. These activity codes are a subset of their respective purpose codes. For example, the activity code *11220.03: Basic education infrastructure* is found under *11220: Primary education*.

#### **5.4. Sector Coding Methodology**

The AidData coding process includes three steps: first code round, second code round, and arbitration. During each code round, an AidData team member reads all available descriptive information for a project and assigns a single purpose code, one or more activity codes and, if appropriate, technical assistance or feasibility study markers. After a project has been coded twice, another team member reviews the two code rounds, ensuring that all aspects of the project were captured by the coders. In some cases, activities are “auto-arbitrated”: when both code rounds agree on purpose, technical assistance and feasibility study, AidData’s internal software assigns the activity codes from both code rounds.
